1. Previous minutes approved.

2. New Business

- Closing for Covid-19 protection Already two clients are being kept home. The case
 was made that it is inevitable that one of the staff will become infected, not know it, and
 spread the infection to our very vulnerable clients. Also Mary Wade and Clelian are
 both closed already as are many other ADCs in the state.
 - Motion made by Pat Seconded by Llz: Partnerships will close end of Friday and remain closed indefinitely, to be revisited regularly (every other week at least) by the Board.
 - Vicki will issue staff layoff notices but she will remain on duty for an extra week. She will call clients (phone). Staff to be advised that Yale, probably among others, is looking for temporary medical staff including CNAs.
 - Shirley will write up something to send (mail?) to clients.
 - Motion passed unaniimously.
 - We might consider looking into non-profit grants (and loans?).
 - Partnerships will reopen without MB see below.
- The MaryBeth problem Her letter to Vicki(!) implies her intent to quit.
 - Reasons we would be better off with replacing her (as put forth by various Board Members)
 - She takes off more time than she has earned
 - She is a disaster at organizing
 - She loses important tools and papers
 - She seems unable to handle more than one thing at a time (e.g., doing managerial work while also aiding CNAs)
 - Remaining on site til closing when needed even if she came in early
 - Asking for an advance on leave, promising not to ask or take more than that and then going ahead and scheduling more leave time for herself
 - She scares prospective clients away.
 - She does not follow up (clients, resources, etc)
 - She has foisted off a great deal of her work onto Vicki
 - Her letter of intent was sent to Vicki, not the Board. Vicki is not her boss, the Board is.
 - Other considerations
 - Her contract was for a year, open ended but with a "fire at will" clause. Shirley will speak to a colleague who has employment experience to be able to compose an effective letter of termination.
 - MB is already collecting unemployment while we are closed for the Covid-19 pandemic.
 - Reopening with new Director we have three options: either of the two people I

recommended or the Dawn/Lucille combo (recall Dawn is only an LPN and Lucille is in her 70s with other commitments).
